



## SON & DAUGHTER SCHOLARSHIP PROGRAM

### APPLICATION CRITERIA

1. Applicants **must** be a full time student at an Accredited College or University, or show proof they will be attending full time in the upcoming semester. The student may be enrolled in a field of study of their choice. Applicant must be a resident of the state of Arizona.
2. Applicants may be the dependent of an association member. This membership can be an individual membership, employee of a firm that has a current membership or a dependent of a supplier member.
3. To be eligible for an Arizona Funeral, Cemetery & Cremation Association Scholarship the following items must be submitted:
  - a. A cover letter explaining why applicant believes he/she is a worthy candidate for the scholarship (financial need will be taken into consideration but is not the determining factor.)
  - b. If there is a tie to the association via membership a letter from the firm, individual or supplier stating the association relationship.
  - c. An **essay**, not less than 1000 words or more than 2500 words, explaining the educational and career path the applicant is pursuing. The winning essay may be published and the applicant, by his or her submission, waives any copyright or other intellectual property rights over the same.
  - d. A **letter of recommendation** from someone in your community.
  - e. Maintain a **3.5** grade average.
4. Scholarships will be awarded at the sole discretion of the Board of Directors of the Arizona Funeral, Cemetery and Cremation Association. Awards will be based on evaluation of the required essay, the general professionalism of the submission, the letter of recommendation and perception of need. Essays must be typewritten and double-spaced with one-inch margins. Essays containing spelling, punctuation or grammatical errors will be subject to automatic disqualification.
5. This is a scholarship and not a loan program. Scholarship awards will be paid directly to the student at graduation.
6. Applications must be received by December 15<sup>th</sup> of each year.
